A **\$100 non-refundable deposit**, made payable to Rev. Ann Marie Acacio is required to hold your date and time and is to be included with this form when reserving the date for your wedding. Your date and time will not be held until the completed form and deposit is received by the minister.

The balance of the honorarium for the Ministerial services is to be made payable to the Minister and is due to be received by the minister, along with the marriage license, one week before the day of the wedding.

**If you cancel your wedding within 60 days of your date, the full balance will still be due!**

A sample copy of the wedding ceremony (which is flexible, along with suggested readings, vows, and ring blessings, will be sent to the couple after receiving the completed wedding application and deposit. Please review the materials, make your selections, and be prepared to discuss them with Rev. Ann Marie when you meet. In order for your wedding to be totally unique and special, Rev. Ann Marie welcomes your ideas and will work with you to incorporate them into the wedding ceremony.

Rev. Ann Marie appreciates a reasonably-prompt start to the Wedding Ceremony. She acknowledges that unforeseen circumstances may delay the start; however, any delay beyond thirty minutes may result in an additional fee of \$50.00 for each thirty minute increment of time.
